impact of the 1996 act on economic welfare in the United States and how the act and its antecedents affected the major telecommunications providers He argues that the act was far too stringent inviting the Federal Communications Commission and state regulators to micromanage competitive entry into local telecommunications markets Combined with the bursting of the dot com and telecom stock market bubbles this aggressive policy invited new and existing firms to invest billions of dollars unwisely leading to the 2001-02 collapse of equity values throughout the sector New entrants into the market invested more than 50 billion in unproductive assets that were quickly wiped out through massive failures The 1996 act allowed the independent long distance companies such as MCI and AT T to live a few years longer But today they are a threatened species caught in a downward spiral of declining prices and substantial losses The industry is preparing for an intense battle for market share among three sets of carriers the wireless companies the local telephone carriers and the cable television businesses Each has its own particular advantage in one of the three major segments of the market voice data and video but none is assured a clear path to dominance Although the telecom stock market collapse is
