THE BUSINESS ENVIRONMENT

Business is defined as any organization or enterprise engaging in industrial, commercial, or professional activities. A business can be:

- A variety of markets, including for-profit, nonprofit, and governmental or public administration
- Any practice of:
 - Making, buying, selling, or providing services in exchange for money (**for-profit**)
 - Supporting, developing, or implementing activities to support societal and charitable needs (**nonprofit**)
 - Creating or practicing activities to support government needs or activities for society or community needs (**public administration**)

Business Factors

- **Supply & Demand:** amount of a commodity, product, or service desired by the customer base (**demand**) and the tangible product, commodity, or service produced and quantity to meet that demand (**supply**)
- **Economic** means resources are used to produce goods and services for commercial or nonprofit use
- **Economic** types of business dealings taking place in certain markets
 - **Free-market:** based on developing or third world countries where goods and services are provided governmentally
 - **Command:** government owns the business and controls the economy, making the decisions on business dealings and opportunity

• **Market:** any enterprise, citizens and businesses act free to make their own decisions of what to buy and sell, and how to conduct their business

- **Competitive:** competition of an industry offering similar products or services to consumers in a free enterprise market economy
 - **Monopolistic competition:** many sellers or competitors offering similar products or services, but each seller has unique differentiators or features or benefits
 - **Oligopoly:** fewer sellers or competitors with less choice differentiator
 - **Monopoly:** only one seller in a market offering a single unique solution. Legal of patent, illegal if does not allow for free enterprise of competition
- **Factors in the macroenvironment:** influences such as politics, law, societal norms, and other emergent issues that determine business objectives and outcomes

EN: Critical IP changed many business operations, opportunities, and objectives due to varying changes in market and consumer needs or behaviors

- **Factors in the microenvironment:** opening channels of communication from employees directly to leadership could improve cultural intelligence
 - Influences the decisions of individuals on the basis of business practices, challenge, or compromise
- **Technology:** continuously advancing to enhance business planning and operations and keep pace with developing new consumer or market needs

BUSINESS TYPES

A business can be classified as small, medium, or large, depending on employee size and annual revenue earned

Small:

<1,500 employees and under \$10.7M in annual revenue

Small Business

- Small employee base
- Focused customer segment or market
- Often generally as a startup or entrepreneurial
- Usually less focused geography of markets
- Greater leadership and decision-making roles
- Investment capital can be limited or specific
- Can be sole proprietor or single owner
- Low-level dependence on technology in some businesses
- Flexibility is greater than larger organizations to test the market

Medium:

between 1,500 and 2,000 employees with annual revenue above \$10.7M to \$1B

- Many are privately owned
- Multiple divisions, business units, and/or service work environments or operations
- Technology dependence medium to low
- Limited geography or markets
- Capital investments slightly larger and flexible

Large Business

- Usually global in scale
- Highly specialized roles and departments
- Operates as corporations or large enterprises
- Many stakeholders, services, and/or departments
- Wide range of customer segments and markets base
- Usually, has the most competitive environment and market dynamics
- Higher capital investment ability
- Higher dependence on technology
